*RESOLUCIÓN do 7 de febreiro de 2019, da Dirección Xeral de Orientación e Promoción Laboral, pola que se procede á publicación das subvencións concedidas en virtude da Orde do 7 de marzo de 2017 pola que se establecen as bases reguladoras e se procede á convocatoria pública de subvencións para a programación de accións formativas dirixidas prioritariamente ás persoas traballadoras desempregadas na Comunidade Autónoma de Galicia, correspondente aos exercicios de 2017 e 2018 (código de procedemento TR301K).*

A Lei 9/2007, do 13 de xuño, de subvencións de Galicia (DOG núm. 121, do 25 de xuño), dispón no seu artigo 15.1, relativo á publicidade das subvencións concedidas, que os órganos administrativos concedentes publicarán no *Diario Oficial de Galicia* as subvencións concedidas con expresión da convocatoria, o programa e o crédito orzamentario a que se imputen, o beneficiario, a contía concedida e a finalidade ou finalidades da subvención.

A Orde da Consellería de Economía, Emprego e Industria do 7 de marzo de 2017 (DOG núm. 59, do 24 de marzo), estableceu as bases reguladoras e procedeu á convocatoria pública de subvencións para a programación de accións formativas dirixidas prioritariamente ás persoas traballadoras desempregadas na Comunidade Autónoma de Galicia, correspondente aos exercicios de 2017 e 2018 (código de procedemento TR301K).

A convocatoria tiña como finalidade concretar os principios xerais contidos na Lei 9/2007, do 13 de xuño, de subvencións de Galicia, no relativo ás axudas para os cursos de formación profesional para o emprego así como determinar os criterios e o procedemento a seguir na execución de accións formativas dirixidas prioritariamente a mellorar a cualificación profesional das persoas traballadoras desempregadas correspondentes aos exercicios de 2017 e 2018.

O financiamento das axudas previstas na orde de convocatoria efectuouse con cargo ás aplicacións e créditos orzamentarios 09.41.323A.460.1, 09.41.323A.471.0 e 09.41.323A.481.0.

As ordes da Consellería de Economía, Emprego e Industria do 26 de xullo de 2017, DOG núm. 148, do 4 de agosto, e do 22 de setembro de 2017, DOG núm. 188, do 3 de outubro, ampliaron a dotación orzamentaria inicial establecida na Orde do 7 de marzo de



2017 con créditos incorporados procedentes de fondos finalistas da mesma aplicación e proxecto que o crédito inicial.
